VOLUNTEER PACKET



Thank you for your interest in being a volunteer at your child's school. Please read this packet carefully, as it contains the requirements for being a volunteer and how to complete those requirements. Please fill out and return all papers contained in this packet to the school office before beginning your volunteer work.

The Archdiocese of Chicago Office of Catholic Schools requires that employees and volunteers working in Catholic schools complete the safe environment protocols for the protection of children and youth before service begins. Parents and guardians shall complete the Safe Environment Requirements before participating as a volunteer in the school as a chaperone, coach, tutor, or in any other capacity with students.

The following Safe Environment Requirements must be completed by all school volunteers over Age 18:

- Attend VIRTUS/PROTECTING GOD'S CHILDREN FOR ADULTS[™] before beginning a volunteer position in the school. All adults over age 18 must pre-register online to attend this one time, 3 hour training. You will also complete a background check through VIRTUS. Additionally, you will need to take an online refresher course every 3 years.
- **CANTS 689 Form** (Child Abuse and Neglect Tracking System) submitted annually to the school office.
- CANTS 22 Form: Acknowledgement of Mandated Reporter Status
- Mandated Reporter Training: Completed every 3 years
- Archdiocesan Standards of Behavior: This is found on your Virtus account. Please download a copy and digitally sign. Paper copies are available upon request.

CBC: Name-based criminal background check run through **VIRTUS online** as part of the VIRTUS registration process. Rechecked every three years through VIRTUS. (Policy 603.2)

FP: Fingerprints run through Accurate Biometrics for the Archdiocese of Chicago. All new hires/school employees may not begin work until fingrprints have been submitted. Schools have the necessary forms.

Child Abuse & Neglect Tracking System (CANTS 689):Yearly check of the central registry of Department ofChildren and Family Services. (Policy 603.5)English CANTS 689 FormSpanish CANTS 689 Form

ADULT TRAINING THROUGH VIRTUS SYSTEM

PGC: Protecting God's Children training session. Register and attend immediately after beginning work or volunteering. (Policy 603.3)

A Plan to Protect God's Children Recertification Training 4.0 with Technology is a 3-year recertification program completed online through the VIRTUS system. Replaces Keeping the Promise Alive. (Policy 603.7)

VAT: Vulnerable Adult Training online training for those who minister solely to vulnerable adults. Replaces PGC for Ministers of Care.

Those under the age of 18 are unable to meet safe environment compliance requirement. Therefore, they may not be in a supervisory role or in charge of minors. **HT: Healthy Teens** is an age-appropriate training for minors who are employees.

PAC: Protecting All Children is training for Chicago Public School staffing and vendors in archdiocesan schools.

MRT: DCFS-Mandated Reporter Training is available through the VIRTUS system. Recertified every three years, including re-signing the Acknowledgment Form (CANTS 22 or CANTS 22A for clergy). Certificates and signed forms are to be kept on file. (Policies 603.6 and 603.7) Spanish CANTS 22 Form Spanish CANTS 22A (Clergy)

ASB: Archdiocesan Standards of Behavior for Church Personnel Working with Minors and Vulnerable Adults. Read and signed at time of hire and re-acknowledged yearly through the VIRTUS system.

(Policy 603.4) Archdiocesan Standards of Behavior (English) Estándares de Comportamiento Arquidiocesanos (español)

Archidiecezjalne standardy zachowania (polski)

Student training: Every student (K–12) in schools and religious education programs should be offered training annually on sexual abuse prevention. (**Policy 603.7**)

Safe Environment compliance is a condition of employment/volunteering and must be met prior to start date. All compliance recordkeeping is to be verified and tracked within the VIRTUS System Database and reported in the Annual OPCY Audit. (Policy 603.1)

ACKNOWLEDGEMENT OF MANDATED REPORTER STATUS

Abused and Neglected Child Reporting Act [325 ILCS 5/4]. This means that I am required to report or cause a report to be made to the child abuse and neglect Hotline number at 1-800-25-ABUSE (1-800-252-2873) whenever I have reasonable cause to believe that a child known to me in my professional or official capacity may be abused or neglected. I understand that there is no charge when calling the Hotline number and that the Hotline operates 24-hours per day, 7 days per week, 365 days per year.

I understand that in an effort to help mandated reporters understand their critical role in protecting children by recognizing and reporting child abuse/neglect, DCFS administers an online training course entitled **Recognizing and Reporting Child Abuse: Training for Mandated Reporters**, available 24 hours a day, seven days a week.

I further understand that the privileged quality of communication between me and my patient or client is not grounds for failure to report suspected child abuse or neglect, I know that if I willfully fail to report suspected child abuse or neglect, I may be found guilty of a Class A misdemeanor. This does not apply to physicians who will be referred to the Illinois State Medical Disciplinary Board for action.

I also understand that if I am subject to licensing under, but not limited to, the following acts: the Illinois Nursing Act of 1987, the Medical Practice Act of 1987, the Illinois Dental Practice Act, the School Code, the Acupuncture Practice Act, the Illinois Optometric Practice Act of 1987, the Illinois Physical Therapy Act, the Physician Assistants Practice Act of 1987, the Podiatric Medical Practice Act of 1987, the Clinical Psychologist Licensing Act, the Clinical Social Work and Social Work Practice Act, the Illinois Athletic Trainers Practice Act, the Dietetic and Nutrition Services Practice Act, the Marriage and Family Therapy Act, the Naprapathic Practice Act, the Respiratory Care Practice Act, the Professional Counselor and Clinical Professional Counselor Licensing Act, the Illinois Speech-Language Pathology and Audiology Practice Act, I may be subject to license suspension or revocation if I willfully fail to report suspected child abuse or neglect.

I affirm that I have read this statement and have knowledge and understanding of the reporting requirements, which apply to me under the Abused and Neglected Child Reporting Act.
